MLA: Citing Within Your Paper. ... If your list of works cited includes two or more works by the same author, then your citation must reflect the specific text in addition to the author's name. Give the title either in the text or in a parenthetical citation.

When you need to cite a paper in APA style, start with the last name of the author and the first letter of their first name. Then, include the year of publication and the name of the work. After that, add other information depending on the type of reference. Scientific Journals and Articles

Cite your sources both in-text and at the end of your paper. For in-text citation, the easiest method is to parenthetically give the author's last name and the year of publication, e.g., (Clarke 2001), but the exact way you cite will depend on the specific type of style guide you follow.

To avoid self-plagiarism, you should request approval from your instructor to use portions of your prior work, and you also need to provide a proper citation within your paper. If you are citing your own writing from a paper submitted for a previous course, then you would generally cite it as an unpublished manuscript.

In-text citations: Author-page style MLA format follows the author-page method of in-text citation. This means that the author's last name and the page number (s) from which the quotation or paraphrase is taken must appear in the text, and a complete reference should appear on your Works Cited page.

How to Cite Yourself If you cite or quote your previous work, treat yourself as the author and your own previous course work as an unpublished paper, as shown in the APA publication manual. For example, if Marie Briggs wanted to cite a paper she wrote at Walden in 2012, her citation might look like this:

Add your appendix immediately following your reference pages and label it as Appendix A, B, C, etc. Use these labels when discussing the appendix in the body of your paper. In the paper, after the sentence in which you are referencing your appendix, format the in-text citation as (See Appendix A).

Academic papers in APA citation has general writing guidelines. Papers should be typed, double-spaced on standard-sized paper (8.5" x 11") with 1" margins on all sides. You should use a clear font that is highly readable. APA recommends using 12 pt. Times New Roman font.

If applicable, help researchers find your work in databases by listing keywords from your paper after your summary. To do this, indent and type Keywords: in italics. Then list your keywords that stand out in your research. You can also include keyword strings that you think readers will type into the search box.

You should use evidence (citations) any time you make a claim that is not based on a well-known fact or common knowledge. Here's a list of situations when your teacher would expect a citation: You make a specific claim that could be challenged--like London is the foggiest city in the world. You quote somebody.

The purpose of your documentation is for your readers to be able to locate the sources which you cite in your text when they look at your bibliography ("Works Cited") located at the end of your paper. You give the minimum of information necessary for your readers to do this, such as just the author's last name and the page (s) to which you refer.

Citing in the body of your paper - MLA Citation Guide ...

When using APA format, follow the author, date method of in-text citation. This means that the author's last name and the year of publication for the source should appear in the text, e.g., (Jones, 1998), and a complete reference should appear in the reference list at the end of the paper.
